Honeytrap No. 2 On July 21, a jeweler living in Katargam fell victim to this honeytrap. The accused had lured him into their trap on social media. After trapping him in the honeytrap, they tried to extort money from him by making serious allegations like rape. After that, the jeweler filed a complaint at the Katargam police station that he had been a victim of fraud, based on which the police have taken further action.

Honeytrap No. 3

A complaint was filed at Laskana police station on July 22, 2025, regarding an incident that took place on May 15, 2025. When the 51-year-old victim, a jeweler, was riding a bike, a woman named Dharmishtha Ruparakholiya from Kamrej side asked for a lift. On the pretext of giving a lift, she sat behind the bike and then informed her gang members. The woman then asked to meet the jeweler and go for a walk. When they went to Galteshwar, gang members Amit Mashru, Sumit Mashru, Alpesh Patel and an unknown person were already present

When the jeweler and the woman were hugging, the gang members reached there and beat them up, handcuffed them and made them sit in their car. They demanded a ransom of Rs 10 lakhs, threatening to implicate him in a drug and rape case. Ratnakalakar gave Alpesh Patel Rs 50,000 from an ATM and the remaining Rs 40,000 was given to the accused by his relative, whose CCTV footage has also surfaced. He also gave Rs 1.5 lakh from a friend and Rs 1 lakh from another person.

A gang's escort who came to collect ransom by trapping a jeweler in a honeytrap has been captured on CCTV. In which the complainant comes to his friend's office to take money. At this time, the accused also lives with the complainant. It has come to light that the complainant borrowed 40 thousand rupees from his friend and gave it to the accused. This entire incident was captured on CCTV.

Revealing that 29 honeytrap gangs are active in Surat, DCP Rajdeepsinh Nakum said in this whole matter, "In the last few days, we have filed three complaints against the Mashru gang in Surat. Our investigation has revealed that as many as 29 honeytrap gangs are active. People from all these gangs are also on our radar and strict action will be taken against them." He added that people working as jewelers in good diamond companies are befriended by women through social media or when jewelers pass by on the road, they trap such women on the pretext of giving them a lift.

When jewelers have physical relations or try to have sex, this gang reaches there and then starts blackmailing them by making videos. Most of the time, these people identify themselves as media persons or journalists and in some cases they also reach there with police identity cards and handcuffs. The most shocking thing about using the codeword "paper has arrived" was that when a honeytrap was successfully set up by a woman, the male members of the gang would use the codeword "paper has arrived" to help maintain secrecy in
